

# **Cookies Policy**

#### 1. About Us - Operator

#### 2. Cookies

A cookie is a small text file that is stored in the user's web browser (e.g. Internet Explorer, Google Chrome, Firefox) on the user's computer (or other device with internet access, e.g. smartphone or tablet). This file ensures that the visitor of our website can easily and quickly retrieve the personalised content whenever they return to a website they have been before. The information from cookies is accessible only to the server of the company that created them, not to any other. A cookie is only a "passive" file, it does not contain any other software programs that could run on the user's device with internet access (computer, smartphone, tablet, etc.). Our website uses cookies. Cookies help us manage our website, provide its basic functionality, and help us understand how users use our website. We also use cookies for analytical and statistical functions, such as recording the country of origin of our website users and the methods they use to visit our website. Cookies also help us serve relevant advertising and personalize our website. Specifically, we use the following types of cookies:

- a) necessary cookies that ensure the proper functioning of our website, for example, they provide the function of logging into a user account on the website or allow you to switch between language versions of our website and ensure that your language selection is remembered. You can disable these cookies by changing your browser settings, but the website may not function properly without them. We process these cookies on the legal basis of pre-contractual/contractual relationships and the legitimate interest of the Company.
- b) **analytics cookies** help us analyse how you navigate our website, what content is relevant to you and also learn more about the demographics of our users. We process these cookies on the legal basis of your consent.
- c) **profiling cookies**, help us to tailor the content of our website to your interests (profiling). We process these cookies on the legal basis of your consent.
- d) **advertising cookies** are used to display targeted and relevant advertising. We process these cookies on the legal basis of your consent.

Some cookies are deleted from your device after you close the browser window (session cookie), other remain stored on your device even after you stop browsing our website (permanent cookie). For information on how long individual cookies are stored, please see the list of used cookies below.

We inform users about the use of cookies on our website via a banner located at the bottom of the website.

## **Google Analytics**

This service from Google Inc. is an analytical tool that allows us to generate statistical outputs about the traffic on our website by storing information in cookies.
